




For those without a SingPass, here is a guide on how authorised person(s) can register on their behalf:

<p><b>Step 1</b></p>	<p>Log on to <a href="http://www.mlc.com.sg">http://www.mlc.com.sg</a></p>	
<p><b>Step 2</b></p>	<p>Click on "Self-Exclusion Listing" found under the "Public" tab.</p>	
<p><b>Step 3</b></p>	<p>Login via SingPass for verification. A One Time Password ("OTP") is required for this process.</p>

Moneylenders Credit Bureau (MLCB) is required to verify submitted documents to ensure that the required documents are submitted.</li> <li>2. Self-excluded individual will receive an email notification once MLCB has verified the documents.</li> <li>3. In the case of an unsuccessful application, both the authorised and self-excluded individual will receive an email notification that the registration has been rejected. You will be required to re-submit the correct documents within 30 days or the application will lapse.</li> </ol>
