






**Guide on how to register for Self-Exclusion Listing:**

<b>Step 1</b>	Log on to <a href="http://www.mlcb.com.sg">http://www.mlcb.com.sg</a>	
<b>Step 2</b>	Click on "Self-Exclusion Listing" found under the "Public" tab.	
<b>Step 3</b>	Login via SingPass for verification. A One Time Password ("OTP") is required for this process.
